<u>Jackson Elementary</u> agrees to implement the following statutory requirements:

 - Student's reports will be sent home by mail and the parents will be able to access the report in Skyward as well
- 7. <u>Jackson</u> will help parents of children served by the school understand the following topics as appropriate--
 - the state's academic content standards,
 - the state's student academic achievement standards.

- the state and local academic assessments including alternate assessments,
- the requirements of Part A,
- how to monitor their child's progress, and
- how to work with educators
- 8. <u>Jackson</u> will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
 - Offering computer training for Skyward, signing up for free Office 365, Canvas and providing additional training based on the parents' needs
- 9. <u>Jackson</u> will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
 - Providing training and staff development meetings regarding parent involvement and meaningful partnership.
- 10. <u>Jackson</u> will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
